With growing water demands in drought-prone regions, expanding piped distribution networks, and ongoing Lift Irrigation Scheme (LIS) extension works, ensuring high pump availability has become essential. Many LIS projects like the Mhaisal LIS have been in operation since the early 2000s, requiring structured Operation & Maintenance (O&M) practices. In this regard, the Water Resources Department (WRD) aims to develop comprehensive Standard Operating Procedures (SOPs) covering O&M, repair management, inventory handling, manpower planning, safety protocols and compliance reporting. These SOPs should align with benchmark practices while reflecting ground realities and WRD's operational experience. Consultants are invited to submit budgetary offers for this study, to be completed within three weeks of the work order, via email, post, or by hand within 8 days of notice publication.



1	<p>To develop comprehensive Standard Operating Procedures (SOPs) covering O&M, repair management, inventory handling, manpower planning, safety protocols and compliance reporting. (Total Timeline – 3 Weeks)</p> <p>Consultant will support WRD in preparing a well-structured SOP manual for O&M and repair management of LIS infrastructure, specifically focusing on aging schemes like the Mhaisal LIS. In the first week, the consultant is expected to carry out a rapid assessment of existing infrastructure, review available maintenance records, and interact with key WRD personnel to understand current practices and challenges. The second week shall involve benchmarking best practices from similar schemes (state and national level), gap analysis, and drafting of tailored SOPs covering preventive and breakdown maintenance, safety protocols, inventory management, manpower deployment norms, and documentation/reporting formats. In the third and final week, the consultant will finalize the SOP manual incorporating WRD feedback, develop checklists/templates for day-to-day operations, and prepare a presentation to facilitate capacity-building within the department. The consultant is also expected to outline a simple high level monitoring framework to assess SOP compliance and maintenance effectiveness over time.</p>	1	Lump-sum


